



The meeting this year presented a change in the format of all the previous. Only one day, Thursday, was reserved to conduct the various National Committees closed session deliberations. This made for a very intense day. In a departure from previous USPS National meetings, Friday's events began with a Keynote speaker, Astronaut Story Musgrave. His presentation, during the Friday member breakfast, reflected on how anything can be accomplished with the right frame of mind, and the willingness to persevere.



After Dr. Musgrave's enthusiastic opening remarks there were other 45 minute seminars and programs throughout the rest of the day, and you could attend as many as would fit your schedule. Topics ranged from Amateur Radio to Web Page and Social Network development, and crossed all USPS departments.

Saturday brought the General Meeting. A ball room filled with over 600 white shirted delegates representing USPS Districts and Squadrons was a site to behold. Partner group representatives were introduced and included:

Jeff Hoedt, Chief, Boating Safety Division, Office of Boating Safety, United States Coast Guard Ken Forster, Chief, Marine and Chart Division, National Oceanic and Atmospheric Administration Thomas Mallison, National Commodore, U.S. Coast Guard Auxiliary Mary Larsen, Coordinator, USCG America's Waterway Watch Program Ev Tucker, Treasurer, National Boating Federation Keith Christopher, National Director, Boy Scouts of America Richard Bee, Chief Commander, Canadian Power & Sail Squadrons Chris Edmonston, President, BoatU.S. Foundation Virgil Chambers, Executive Director, National Safe Boating Council Carolyn Belmore, President, National Boating Federation Larry Bowling, National Transportation Safety Board Steve Prime, Vice President, Gowrie Group Jake Hill, Executive Underwriter Manager, McGriff, Seibels & Williams Kirsten Schuchardt, Marketing Manager, Brunswick Dealer Advantage Randy White, President and Chief Executive Officer, SailAngle.com

Various Committee Chairs and Bridge Officer gave accounts of their department's respective activities and some highlights are below.

Headquarters Staff:

In June USPS received three USCG grants totaling \$454,900. The first is the Practical On-the-Water Training Rollout Grant Phase III for \$220,000. Funding will be used for advanced training, integration of courses with on-water components, training additional instructors and students, marketing, and data analysis. The second is a USPS Partnering Grant for \$19,900 to fund travel to facilitate partnering objectives. The third is a USPS Boat Handling Simulator Program for \$215,000. Funding will be used to purchase portable boat handling simulators and for marketing and administrative costs.

Planning Committee:

The Planning Committee submitted its report to the Board of Directors on alternative sources of revenue that would be in addition to dues and sales of educational materials. The committee is working on squadron simplification and is working

with the Board of Directors to develop a new Strategic Plan that will contain goals that are meaningful, achievable, and measurable. R/C Simkins reported that the Planning Committee presented a seminar on electronic meetings. The presentation can be downloaded at *usps.org/national/plancom/resource*.



Finance Committee:

R/C Popham reported an operating surplus of \$66,711 as of 31 July 2013, compared to an operating deficit of \$42,268 one year ago. He noted the surplus was due primarily to reducing expenditures. He noted that the necessary actions had been taken to reduce the operating deficit, and that the Finance Committee believed that USPS should achieve break-even operating results in 2013. He reported that the 2014 Budget contemplates a break-even operating result and that the Finance Committee determined that the funds necessary to finance the 2014 Budget could reasonably be anticipated. R/C Popham announced that the Finance Committee Report was not recommending a dues increase in 2014. R/C Popham reported that the Board of Directors recommended reinstating an administrative fee for new primary members. He explained that in the past new members paid a \$25 initiation fee to cover administrative costs. The Governing Board voted to eliminate that fee beginning in December 2010 with the hope that it would help attract new members. Eliminating the fee has cost USPS approximately \$200,000 and has not had a positive effect on recruiting new members. He explained that the proposed administrative fee will be billed when a primary active member joins or, in the case of a free trial membership, on the first dues invoice.

National Treasurer:

V/C Cheney reported that as of 31 July 2013 operating revenues were up slightly from the prior year and expenses were down approximately \$105,000, with a net gain of \$67,000. He anticipated that 2013 finances would end on a breakeven point. As of 31 July 2013, non-operating revenues over expenses were \$317,000, also an improvement over the previous year, resulting in total operating revenues over expenses of \$384,000. V/C Cheney reported that the Board of Directors approved a break-even budget for FY 2014. V/C Cheney concluded by saying that the overall financial condition of USPS had improved a great deal over the previous year and thanked all who had contributed.

Secretary:

National V/C Jean L. Hamilton, SN, reported on the USPS website redesign project. She reported that the site has been divided into two sub-sites: an external site, which includes much of the current website content; and an internal site, which includes member tools and pages used by members and officers. She noted that the sub-sites will appear as one site in the final product. The Website Content Team had submitted all material for the external site following a significant outline revision in June. The outline for the internal site was completed, and discussions are still in progress as to logistics of scripts, tables, and programming language for content. The Planning Team met in San Antonio to discuss the logistics of implementation, testing, and webmaster training.

National Administrative Officer:

The Membership Department is updating the Membership Manual. Membership recruitment and retention tools are available on the committee's website at *usps.org/national/membership*. The Member Benefits Committee developed a new Member Benefit District Table Kit containing PowerPoint files, fliers, handouts and display tips and ideas, which is available on the committee's website at *usps.org/national/admin_dept/membenefits.htm*. /C Ojeda reported that the Squadron Development Committee is working on developing squadrons in six new locations.

National Education Officer:

National /C Bob Brandenstein, SN, reported that the Educational Department is making progress on implementing online seminars in partnership with the BoatU.S. Foundation. The Partner in Command online seminar is live and has already been taken by a number of non-members. The goal is to make all seminars available to non-members. Boating on Rivers, Locks and Lakes will go online by the end of October 2013.



National Executive Officer:

The Cooperative Charting Committee reported that 12 districts, 43 squadrons, and 194 members submitted Cooperative Charting reports from 1 April through 15 Aug. 2013. Forty-three squadrons and 70 members achieved Honor Roll status. The Environmental Committee is working on proposals for proper flare disposal. The committee has received additional information from its members in California about new restrictions on practice flare shoots in certain areas of the state. In addition, it now appears that the USCG and the USCG Auxiliary will no longer accept donated expired flares from individuals and outside organizations in parts of California. V/C Baldridge moved that the Governing Board approve holding the 2015 Governing Board at the Manchester Hyatt in San Diego, Calif., from 30 Aug. to 6 Sept. 2015 at a room rate of \$145 per night. The Governing Board ADOPTED the motion (2013-GB-5). The Safety Committee reported that 2,107 vessel examiners completed 29,412 vessel safety checks in 2013. V/C Baldridge reported on the Recreational Boating Safety Visitation Program with the USCG Auxiliary. A training seminar will be held during the 2014 Annual Meeting to certify program visitors. The national executive officer reported that the Board of Directors approved the Marinette & Menominee Provisional Power Squadron, to be assigned to District 10 for administrative purposes.

It was a busy four days, but also a lot of fun. The Friday night hospitality rounds and visiting with friends old and new throughout the convention are always refreshing and insightful. If you have never attended a National Meeting, I urge you to try one out, it just may be one of the best events you will ever attend. Hope to see you in Jacksonville, Florida for the Annual Meeting and the conclusion of the USPS 100th anniversary celebrations.



hen I was in school, I was terrified to stand up in front of the class and speak. Fortunately, things change and in my professional life, I had many occasions to conduct meetings, to give presentations, and even to provide co-workers with formal instruction and I achieved comfort in doing so. Nearly twenty years ago I joined the United States Power Squadrons and gained knowledge in all its possible courses. This segued nicely into the next phase of my life, teaching its classes and seminars.


This highly-regarded nationwide not-for-profit recreational boating education organization offers courses in basic boating safety, seamanship, navigation (with terrestrial references and celestial) and "elective" courses in subjects such as Engine Maintenance, Marine Electronics, and Cruise Planning. It also offers many seminars on a vast array of boating subjects, and recently, at the encouragement of the United States Coast Guard, initiated an on-the-water training program.


As I began teaching, I realized that knowing subject matter and successfully teaching it to others are two entirely different matters. The Power Squadrons requires volunteer teaching members to learn how to be effective instructors with: preparation of lesson plans, development of teaching aids, successful use of presentation material, and effective delivery of the lessons. After passing a written exam and demonstrating effective teaching, the volunteers are transformed into certified "instructors" with required periodic refresher seminars. Now that young boy who quaked at making a presentation really enjoys getting up in front of the class in order to help others become better (and therefore safer) boaters!

Before you follow my example and volunteer to be a Power Squadron instructor, please be forewarned that you'll start this process at your own risk: teaching is definitely addictive. All class instructors will admit that they really enjoy teaching others to become more competent boaters. With so many teachers yearning for students to come and learn, I encourage you to take some safe boating and skill courses and seminars.

ext season's "Cruise of a Lifetime" starts with today's careful planning. Though the next boating season seems far away, it's not too early to start planning. Whether you take a long or short cruise, on a lake, river, or canal, it's never too early to prepare. A little work in the winter can go a long way to the next boating season.

First of all, get acquainted with the area where you want to cruise. Inquire as to where you can obtain charts, light lists, tide and current tables. Remember to ask for Weather Service Charts. Contact the Coast Guard for information and learn the laws of your cruise area. Learn the location of marinas and what kind of service they provide (i.e. anchorage, etc.). Create a list of all equipment you think you will need, including medical supplies.

Take time to learn the rules of the road. Find areas of shoals and rocks. Check bridge clearances. Become familiar with local lights and daymarks.

Smaller lakes require a plan too

Often no charts are available for smaller, natural, or man-made lakes. When cruising these lakes, knowledge of navigation is not necessary. However, rules and regulations are lake dependant, so take the time to learn these for each lake you cruise. Cruising on the large lakes may require plotting of courses, use of a compass, time, speed and distance calculations, and sometimes bearings and fixes. Excellent Great Lakes Charts are available.

River cruising is different as each river has its own set of rules. Binoculars are the only piloting tools necessary when cruising on a river. You must determine your position by observing landmarks on either side of the river. Use river charts and study the chart legend carefully.

One constant in river cruising is change. The Mississippi and Ohio rivers and other major rivers are constantly changing. Obtain the latest information and talk with local boaters, as they observe daily changes in conditions and can tell you the locations of the latest hazards. Also, the Coast Guard issues "Local Notices to Mariners" with the latest available information.

In addition, when cruising a canal or river which contains locks, familiarize yourself with the locking procedure.

Finally, the USPS Cruise Planning course has much more helpful information on how to plan a safe and enjoyable cruise. Combine the material of the course with facts learned in the Weather course and you can look forward to a very pleasant summer.

CPR & AED

istrict 10 held its Fall Conference in Green Bay the first weekend in November. Included in the list of seminars was CPR AED. Over 30 years ago I completed a CPR (cardiopulmonary resuscitation) course but had not worked with an AED (automated external defibrillator).

AEDs are found in places with many people, such as shopping malls, golf courses, businesses, airports, airplanes, casinos, convention centers, churches, hotels, sports venues, and schools. However, there may not be a person available that is willing to use the unit so it may be up to you.

CPR consists of compressions, (pushing on the chest) and giving breaths. Pushing on the chest causes the blood in the heart to be pushed to other parts of the body including the brain. The rate of these compressions should be at least 100 per minute. After 30 compressions, give two breaths before continuing with more compressions. Each of us took turns on several dummies that were available. We were instructed to determine whether the person is unresponsive, that we sent someone to locate an AED unit and call 911. In working with the dummies, the teaching staff checked that we had the correct hand position on the bare chest for our compressions, that they were deep enough, and that we were positioned to give downward pressure with minimum fatigue to us. In giving the breaths we needed to make sure that the airway is open by positioning the head back. Each of us had several two minute sessions to practice the 30 compressions and 2 breaths under supervision. We also took turns on dummies the size of an infant and one about the size of a child. The overall system is the same with a few adjustments for the size of the person such as using two fingers on an infant.

As soon as the AED unit is available it should be put into use. The AED can be turned on by pushing the "ON" button or simply lifting the lid. Follow the verbal instructions to place the pads on dry skin, stand back so it can analyze the system and it will prompt you when to push the "SHOCK" button. If unsuccessful it will tell you to start CPR. Continue to follow the directions.

The seminar was put on by Jill Noffsinger from Northeast Wisconsin Technical College. . There were 12 of us in the class and all received certification. The ability to work on the dummies gave us the beginning experience that is needed. I would recommend that all of us take a course that gives us the skills to use CPR and an AED. You might be the only one that could save a life.

St. Mary's Challenger On Final Run

fter weeks of speculation, the oldest freighter on the Great Lakes The St. Mary's Challenger and one with a special place in maritime history is unloading its last load of cement, before steaming to Sturgeon Bay, Wis., to be transformed into a barge.

We are talking about a ship that was built before the Titanic, said Richard Jenkins, of Lawrence, Mass., who chased the Challenger from Chicago to Michigan and back. He said the Challenger is the last active U.S. flag freighter built before World War II, and at 107 years, one of the oldest operating ships in the world, which he credited to the fact that for most of her career, she worked on the Great Lakes and not in salt water. The powdered cement delivery, which continued until late Saturday afternoon, marked the conclusion of a second career for the freighter, one which began when she was rebuilt for the cement-hauling trade in 1967-68.

Those who spoke with the crew said the mood on board has become increasingly somber in the past few weeks, as speculation grew about the future of the ship, which is due for a mandatory five-year federal inspection.

Although the Challenger's owner said it was trying to decide between re-powering the ship, the last oil-burning steamship on the Great Lakes, with a new diesel engine and transforming it into a barge, others said the decision was made some time ago and already has a tug waiting in Muskegon, Mich., to begin its pushing chores.

The Chicago History Museum is among those hoping to obtain a piece of the ship as it is transformed. Some ship enthusiasts said they understand the dollars-and-cents decision that had to be made, but Jenkins said they should leave the ship as she is.
